#### Purpose and legitimacy of the treatment

#### Retention of data

Your data will be retained:

- a) In case you have submitted your self-application for a maximum period of 1 year.
- b) If you participate in an open recruitment procedure, until the end of the procedure. They may be kept for a longer period if you give us your consent and/or if we have a legitimate interest in assessing your profile for future processes.

#### Data recipients

Your data will not be passed on to third parties. It will be communicated to our data processors when it is necessary for the correct provision of the services contracted to them.

# Data transfers to third countries

No international data transfers will be carried out.

### Rights of the data subject

- Access: the right to obtain confirmation as to whether or not we are processing your personal data, to know what it is, what it is used for, how long it will be kept, the origin of the data and whether it has been or will be communicated to a third party.
- Rectification: the right to request the rectification of inaccurate data and the completion of incomplete personal data.
- Deletion: the right to request the deletion of personal data when they are inadequate, excessive or no longer necessary for the purposes for which they were collected, including the right to be forgotten.
- Opposition: the right to object, in certain circumstances, to the processing of your personal data or to request that the processing be stopped.
- Limitation of processing: the right to request, in the legally established circumstances, that your data not be processed beyond the mere conservation of the same.
- Portability: the right to receive personal data in a structured, commonly used and machine readable format and to be able to transmit it to another data controller, provided that this is technically possible.



- Right to withdraw consent: you may withdraw your consent at any time. If you withdraw your consent, the data processing previously carried out will continue to be valid.
